## Name, Mascot, Logo and Livery of Merged Airline Announced

Mr Praful Patel, Union Minister of State for Civil Aviation, officially announced on May 22, 2007 that after the merger of Air India and Indian, the new entity would be known as "Air India". While the new company will have its registered office in New Delhi, its corporate office will be in Mumbai and its office for domestic operations as well as the Strategic Business Units will be mostly based in Delhi. The Mascot of the merged airline will be the Maharajah. Simultaneously, the new livery and logo of the merged airline were also unveiled by the Minister.

As "Air India" is a globally and nationally recognised brand name, and the designated airline in international bilaterals - the "AI"

code being available only to the existing name, it has been decided that the merged entity would continue with the same name. The design components of the new logo and livery have been drawn after merging some of the current features of both Air India and Indian.

"The Centaur" whereas the "Konark Chakra" is reminiscent of Indian's logo. The new logo will feature prominently on the tail of the aircraft. Individually the Konark Chakra will also feature on all the engines of the aircraft. The choice of colours, namely

The logo of the new airline is a Flying Swan with the Konark Chakra placed inside it. The Flying Swan has been morphed from Air India's characteristic logo,

red for "Flying Swan" and orange for "Konark Chakra", are meant to signify vigour and advancement. Further, the colours also have a strong association with the two carriers, thereby retaining the earlier imagery of traditional hospitality and service. While the aircraft will be ivory in colour, the base will retain the red streak of Air India. Running parallel to each other will be the orange and red speed lines from the front door to the rear door, subtly signifying the individual identities merged into one. The brand name "Air India" will run across the tail of the aircraft.

Air India Express has introduced five new flights effective its Summer Schedule 2007, which commenced from March 25, 2007. These include:

- Mumbai-Doha/Bahrain,
- Mangalore-Doha/Bahrain,
- Trichy-Dubai,
- Trichy-Singapore, and
- Chennai-Colombo.

### Doha-Bahrain-Mangalore

The maiden flight of Air India Express, IX 814, took off from Doha International Airport for Mangalore via Bahrain amidst fanfare on March 25, 2007 at hours. The flight was flagged off by Dr. George Joseph, Indian Ambassador to the State of Qatar, amidst cheer and good wishes from all who came to see off the inaugural flight. It was operated under the command of Capt. Avinash Chikte with the airline's new Boeing 737-800 VT-

Earlier, a colourful and well attended function took place in the departure lounge, which was graced by representatives of various nodal Indian organisations, media and airline officials. Dr. Joseph inaugurated the flight by cutting the ribbon at the checkin counter and handed over boarding cards to Mr Abdul Salam ad Ms Pushpa Maroly, the first two passengers to check-in for the flight to Mangalore. Dr. Joseph also cut a huge cake decorated with the Indian tricolour, and the logo and flight number of Air India Express.

Speaking on the occasion, Mr Debashis Golder, the then Manager-Qatar, remarked that the new flight would make international travel for a large section of the Indian expatriate community more affordable. Each centre will serve approximately 20 million people. As part of the existing ORBIS Peadiatric Eye Care Centre programme, four child-friendly paediatric eye care facilities have already been established in Maharashtra.

### **Aviation Scenario**

# Passenger Demand on the Rise, Cargo Sluggish

International passenger traffic demand rose 7.8 per cent year-on-year according to March 2007 traffic results released by the International Air Transport Association (IATA) on April 30, 2007. This is the largest year-on-year single month increase recorded in a year. Average international passenger load factors remained high at 76.4 per cent. International freight traffic demand continued a 12-month run of sluggish growth with a 2.3 per cent increase year-on-year.

Comparing the first three months of 2007 to the same period in the previous year passenger demand was up 7.0 per cent with average load factors of 74.9 per cent. Freight demand increased 2.7 per cent.

"The story for passenger traffic is based on strong economies driving the demand to travel for both business and leisure markets. For freight, competition for other modes of transport – particularly sea – is holding growth below our forecast of 5.5 per cent for 2007," said Mr Giovanni Bisignani, IATA's Director General and CEO.

"People want to travel and they are doing it in record numbers," remarked Mr Bisignani. "The fact that airlines are meeting that demand with newer, more fuel-efficient aircraft and near-record load factors bodes well for the bottom line (of the aviation industry) and should lead to an industry profit of US \$3.8 billion in 2007," he added.

### Sale and Leaseback for A310s

Air India, for the first time, invited bids from prospective lessors/bankers under the reverse auction method for the sale and leaseback of the six owned Airbus 310-300 aircraft in our fleet. Air India has, through this transaction, sold the aircraft to a European bank, and leased them back under an operating lease for its operations. The deal, worth US \$80 million, helped Air India to generate cash and unlock the value of its assets.

# Al Bags Ground Handling Contract for New GMR Hyderabad International Airport Ltd.

Air India, along with Indian and Singapore Airport Terminal Services Ltd (SATS), has been awarded one of the two contracts for providing ground handling services at the new upcoming greenfield airport at Shamsabad, Hyderabad, by M/s GMR Hyderabad International Airport Ltd. (GHIAL). The other concessionaire selected by GHIAL is M/s Menezies Boba Group.

GHIAL which is expected to be operational effective March 1, 2008, had earlier floated a tender for appointing ground handling service providers at the new airport.

The total project cost is estimated to be Rs 80

crores. Of this, Rs 60 crores will be equity, which will be shared in the proportion of 26 per cent each by Air India and 25 per cent by Indian, and SATS holds 49 per cent.

Accordingly, while Air India and Indian will contribute Rs 15.3 crores each as share capital, SATS will contribute Rs 29.4 crores. The balance amount will be drawn from commercial banks/financial institutions.

With Indian having their set up at the present Hyderabad Airport, the Air India/Indian/SATS consortium envisages to capture over 60 per cent of the third party handling business at the upcoming airport.

When an aircraft lands at an airport, Ground Services Department personnel carry out a host of activities, such as loading and unloading of baggage, air cargo and air mail, meals, etc. onto the aircraft, and transportation between the aircraft and the terminal. ### Trichy-Dubai/Singapore

## Two More Aircraft Taken on Wet-Lease

Air India, which has since the past few years, been leasing aircraft to meet the growing passenger demand and overcome shortage of pilots, has signed two agreements one with M/s Czech Airlines (CSA) and the other with M/s Globespan Airways – for wet leasing one A310-300 and one B767-300ER aircraft respectively. The lease, initially for a period of six months, is extendable by another six months.

While the A310-300 arrived in India on March 24, 2007, the B767-300 ER was delivered on May 18 2007

With the induction of these two aircraft, there are 50 aircaft in our fleet – 37 for Air India, including 21 on lease; and 14 for Air India Express, including seven leased aircraft. Besides these two aircraft, three other aircraft have been taken on wet-lease in the recent past - two B767-300ERs and one B757-200ER.

## More Flights to London and Dammam

Air India will operate four additional terminator flights a week to London three from Ahmedabad and one from Delhi - following successful negotiation of landing slots with Malaysia Airlines, and two more weekly flights between India and Dammam with effect from June 1, 2007. The flights will be operated with three wet-leased Boeing 767 aircraft, which have a capacity of 24 Executive Class and 220 Economy class seats. With the addition of the new flights, the total number of flights to London will be stepped up to 25 a week, including 15 terminators, and flights to Dammam will be enhanced to 10 a week. The new flights to Dammam will be operated non-stop between Chennai and Dammam on Mondays and Thursdays.

### **Companion Free Scheme Extended**

The validity of the Companion Free Scheme, which entitles passengers to travel along with their partners free of charge, has been extended till March 31, 2008. The scheme is applicable on Air India operated flights for passengers travelling on full published IATA fares in all classes - First, Executive and Economy - for both one-way and roundtrip travel between India and UK/Europe/USA/Canada, and between USA/Canada and

UK/Europe.

Two A310s Converted into Freighter Aircraft

Krishna' (VT-EQS) and 'Narmada' (VT-EQT), two of our Airbus 310-300 aircraft which joined the fleet in August 1990, have been converted into freighters. The task of conversion was entrusted to M/s European Aeronautic Defence and Space Company (EADS), a subsidiary of

After a four-month long conversion process, 'Krishna' was delivered to Air India in Dresden. Germany, on April 24, 2007 and joined our fleet in Mumbai on April 25, 2007. 'Narmada' is scheduled to arrive by May 25, 2007.

The scheme is, however, not applicable on Air India's code share flights. While passengers are required to undertake the first leg of the international journey together, they may travel separately on the return journey. Surcharge is applicable on the companion's ticket only if interline travel is involved.

The Companion Free Scheme will also not be applicable on our direct non-stop services to be launched from Mumbai to New York later this

## Airline Engineering & Maintenance Conference for the Indian Sub-Continent

Mr K.M. Unni, Director of Engineering, Air India Limited, co-chaired the Second Annual Aircraft Engineering and Maintenance Conference for the Indian sub-continent organised recently in Mumbai under the aegis of Aviation Industry Conferences, London, along with Mr Hitesh Patel, Executive Vice President, Engineering & Operations, Kingfisher Airlines.

A number of interesting presentations were made on the occasion and well received by an appreciative audience of about 125 aviation industry professionals from India and abroad.

Mr Ashwani Sharma, Regional Maintenance Manager (UK & Europe), made a presentation on 'Aircraft Fuel Tank Maintenance Post Crash of Flight TWA800 - Regulations & Maintenance Practices'. In his speech, Mr Sharma traced the history of changes in fuel tank maintenance practices in light of various Federal Aviation Administration (FAA) airworthiness directives following the tragic crash of flight TWA800 in July 1996. Earlier in July 2006, Mr Sharma made a similar presentation before students and faculty of the Engineering Department of Imperial College, London.

## IAF Pilots to Join Air India

Air India and the Indian Air Force (IAF) signed a Memorandum of Understanding on April 5, 2007 whereby the IAF will be releasing pilots regularly to serve the national airline. The highly skilled Air Force pilots come with years of experience. This move will help Air India cope with the industry problem of pilot shortage, and emerge as a stronger and more efficient airline.

The first 13 pilots from IAF – six Air Vice-Marshals, six Air Commodores and a Group Captain – will be released shortly to undergo training on Boeing 737-800 aircraft of Air India Express.







# Global Tender for Overhaul/ Repair of Bangladesh Biman Airlines' P&W Engines Bagged by AI

Air India has bagged the global tender for carrying out overhaul/repair for aero engines belonging to Bangladesh Biman Airlines. The terms of contract also include providing on-wing support to Biman's engine fleet at Dhaka and at other stations. The period of contract is three years and the approximate value of the contract is US\$20 million.

Biman's Airbus fleet is powered by Pratt & Whitney 4000 engines. The first engine, which had been successfully overhauled, has met the stringent turnaround time and repair cost requirements.

Air India's Engine Overhaul Department, which is approved by the Federal Aviation Administration (FAA) and the Directorate General of Civil Aviation (DGCA), the Indian regulatory authority, performs third party repair/overhaul of jet engines belonging to customers located across the globe. The current list of our customers include:

- Cromalloy Gas Turbine Corporation, USA
- Chromalloy Engine Management Services, USA
- Kellstrom Industries, USA
- Aviation Trading & Leasing Inc, USA
- Star Aviation FZC, UAE and
- israel Aircraft Industries, Israel.

In addition, besides overhauling and repairing engines installed on our own aircraft, the Engine Overhaul Department carries out overhaul and repair of all PW4000 and CF6-80C2 engines installed on the leased aircraft operated by Air India. The engines are owned by various lessors, viz. Korean Air, Singapore Airlines, Boeing Aircraft Holding Co. Aviation Lease and Finance Company (ALAFCO), Constitution Aircraft Leasing limited, Guggenheim Aviation Partners, etc.

Air India has, during the financial year 2006-2007, overhauled or repaired eight PW4000 engines and five CF6-50C2 engines, and thus earned revenue of over US \$2.5 million by way of labour and handling charges.

# **Air India Express Receives Seventh B737-800 Aircraft**

The seventh Boeing 737-800 aircraft owned by Air India Express, VT-AXQ, which was delivered in Seattle on May 14, 2007, arrived in Mumbai on May 21, 2007.

Like the earlier Air India Express aircraft, its tail designs are a novel feature. The new aircraft showcases landmarks of Delhi – Kutub Minar on one side and Jantar Mantar on the other side.

**Kutub Minar**, the tallest brick minaret in the world, is made of fluted red sandstone covered with intricate carvings and verses from the Koran, the holy book of Islam. A remarkable example of Indo-Islamic Architecture, the monument is listed as a UNESCO World Heritage Site.

Qutb-ud-din-Aybak, the first Muslim ruler of Delhi, started

to build it in 1200 AD. Later Iltutmish, his successor took over and finally it was completed in 1368 by Firuz Shah Tughlak.

Jantar Mantar, a unique structure, raised in 1724, now lies near Connaught Place in the heart of Delhi's commercial centre. Jantar Mantar is actually pronounced as 'Yantra Mantra' — Yantra for instruments and Mantra for formula. The various abstract structures and a sun dial are instruments which were used for keeping track of celestial bodies like the sun, moon and planets. Jantar Mantar tells a lot about the technological a chievements under the Rajput kings and their

attempt to resolve the mysteries regarding astronomy. It is one of the astronomical observatories raised by Maharaja Jai Singh of Jaipur, others being located at Jaipur, Varanasi, Ujjain and Mathura.

Following the induction of this aircraft, the fleet size of AI Express has been enhanced to 14 – seven owned and seven on lease.

### **E-Ticketing Through Travel Agents**

Passengers can now purchase e-tickets in India through travel agents using the Amadeus Global Distribution System (GDS). The facility is available for travel between Mumbai, Delhi, Hyderabad, Bangalore, Kolkata, Ahmedabad, Chennai, Kochi and Thiruvananthapuram in India; London in the UK; and New York, Newark, Chicago and Los Angeles in the USA.

This is a significant step for Air India in its endeavour to make 100 per cent E-ticketing a reality by the IATA deadline of December 2007.

Travel agents will benefit greatly in terms of improved efficiency in passenger servicing and reduced costs, thereby enhancing their productivity. Passengers will be able to enjoy easier and more convenient travel experience with no hassle of carrying tickets and hence no possibility of lost or misplaced

tickets as the electronic image of the passenger's ticket is stored in the computer system of the airline which obviates the need for a paper ticket. This also streamlines and simplifies the airline's sales and accounting processes apart from providing significant cost-savings over paper tickets.

The first e-ticket through Amadeus on Air India was issued for Mr Ramchandra Singh. He had purchased his ticket from Akbar Travels at 12 noon on March 10, 2007 for travel from Mumbai to London by Al-111 of March 18, 2007.

Passengers will shortly be able to book their seats through travel agents using Sabre, Abacus, and other GDSs.

Air India will also, in the ensuing few months, implement the e-ticketing facility for interline / code share partners.

Satyam Computer Systems, based in Hyderabad, has been selected by the Department of Information Technology as implementation partner for the project. ERP has earlier successfully been deployed in the Materials Management Department.
