Life is a one-way street and man only moves forward in time. The phenomenon of ageing is thus inevitable. In fact we begin to age from the very moment we are conceived and the two processes of growth (evolution) and atrophy (involution) are set in motion at that very moment. While growth dominates in earlier years, atrophy is the rule at older age.

But old age is not a disease. People do not suffer old age but with disease which strike with increased frequency at that stage in life. Much ill health can be prevented or its onset delayed and suffering avoided by applying the current knowledge about these so-called "anticipatory diseases". In fact 40 years is approximately the cut off point marking water-shed in the health scale of man. To understand this, it is necessary to first understand the changes which take place in the body with time. In this article we will, therefore, discuss about the physiologic changes which take place with ageing. The next article will present information diseases of old age and how to prevent and manage them.

All physical structures in nature are subject to change - some more rapidly, and others less so. The basic units of which the human body is made, namely the proteins, are themselves subject to physical changes of significant magnitude. As time passes, protein molecules

undergo these changes and tend to become unsuited for the functions they are meant to perform. It is estimated that these changes become so numerous and extensive in about 125 years from the beginning of life that it would be impossible for the original body to survive beyond this period. Theoretically, therefore, human life span cannot exceed 125 years.

The body composition begins to alter significantly about the age of 40, when the cells of which it is made begin to die in greater numbers. These are not fully replaced. In fact even the partial replacement of these is such that the specialised cells are not replaced by specialised but by inferior cells thus leading to decrement in the functional capacity of various organs of the body. The muscles and other tissues are reduced in bulk. However, the fat continues to increase in the body so that overall body weight remains constant.

The total amount of blood in the body decreases as also the hemoglobin level. As such slightly low hemoglobin level in the elderly does not necessarily mean anemia.

Calcium is removed and the bones become more susceptible to fractures. It is uncertain whether the virtually universal occurence of osteorithritic changes in many joints is an effect of age, the response of joints to time-related

wear and tear or a disease process unrelated to age. But the fact remains that these changes are more or less universal in the elderly. The serum calcium level declines. Before the menopause serum calcium concentration are lower in women than in men and reverse is true of thereafter. The muscles shrink in size and become weaker and inefficient.

The most important changes with age are seen in the cardiovascular system. The fibrous tissue increases and the elastic tissue decreases in the heart and the blood vessels. The pumping action of the heart is reduced leading to a fall in cardiac output. The upper or the systolic blood pressure generally rises with age but the diastolic or the lower pressure may or may not show this trend.

In addition to changes mentioned above the deposition of cholesterol and other changes lead to thickening and narrowing of arteries with decrease in blood supply to the vital organs. The decline in functional capacity of heart and increased destruction of brain cells and functions are in part due to this. Strokes and heart attacks may ensue.

The pattern and quality of sleep changes with age and insomnia is common.

Due to decrease in elasticity of lungs and in strength of respiratory muscles, the capacity of respiration declines. The elderly are unable

to expel secretions from the lungs effectively.

Infections of the gum are common in the aged and the teeth are gradually lost. The enamel of the remaining teeth wears out. While in animals the loss of teeth, signals the end of their lives, man can compensate with artificial teeth. Only minor changes occur in the liver and small intestine. The movement of large intestine becomes diminished. Atrophy of the stomach lining is common with advancing age.

The metobolic rate drops by 30% and as such the quantity of food required also decreases. However, the quality of food should be improved as absorption may be deficient because of the changes mentioned above. Therefore easily digestible foods giving more iron, calcium and vitamins are necessary.

The kidney function declines with age. Water conservation becomes less efficient in man the prostate gland enlarges causing disturbances in urination.

Sex life is reduced and its psychological components variously affected in different individuals.

The secretion of various hormones declines to some extent. The loss of mensturation i.e. menopause is a consequent of this and indicates a decline in ovarian secretions.

Changes in eyes and ears are well documented. The lens becomes less elastic and changes of cataract set in. The eyes sink, eyelids drop, wrinkles appear around the eyes and the cornea shows arcus senilis. Similarly, the acuity of hearing decreases, specially for high pitch sounds. The senses of taste and smell are also dulled.

Perhaps the most striking changes, because of their visibility are in the skin; it becomes less elastic and wrinkles and because of increasing dryness there is more itching. The hair turn grey and fall out specially in men.

Like other specialised cells of the body the neurones in the brain and the spinal cord also die and are not replaced. Even the remaining cells undergo degenerative changes. As a result of these changes and deficient blood supply referred to earlier, disturbances in the functions of the brain and other parts of the nervous system are common in the aged.

The overall capacity of body to fight the on going deleterious effects of the environment and invasion by micro-organisms decreases. As well as this, changes in the very basis of life, the DNA and RNA which form the genetic code of the cells, leads to unregulated and uncontrolled cell pilferation and higher incidence of malignancies. But, as mentioned earlier, much suffering and ill health in old age is man-made and can be avoided. We will discuss more about these and preventive and curative aspects of the diseases of old age in the next article.

### Flying eye hospital

MOTHER Teresa recently inaugurated an eye hospital aboard an aircraft at Calcutta airport; it has created an unprecedented enthusiasm among patients in the eastern region of the country, who have been clamouring for free treatment and operations by a team of eight overseas surgeons of repute.

The then union minister of civil aviation, Madhavrao Scindia agreed to provide free landing and parking facilities for the aircraft at Calcutta airport.

Project Orbis is an international, non-profit organisation that combats world blindness through education and hands-on training. Its principal vehicle for work is an old forjet DC-8jet donated by United Airlines.

Housed on board the converted aircraft is a fully-equipped

opthalmological teaching hospital, complete with an examination and laser treatment area, operation theatre, recovery room, audio-visual television studio, 8-seat classroom, scrub and substerile area, as well as library for videotapes, text books and current journals.

The airborne project was conceived by Dr. David Paton, a Texan opthalmologist in the mid '70s. The US Agency for International Development then provided a starting grant at d United Airlines donated the aircraft.

According to an Orbis spokesman, to date they have circled the globe three times, carrying out more than 100 sight-saving training programmes in more than 60 countries.
