NOTICE :

The carriage hereunder is subject to Indian Airlines Non-International Carriage (passenger & baggage), conditions of carriage framed by Indian Airlines Ltd. as applicable on the date of carriage. The liability of Indian Airlines Ltd. for damage sustained in the event of the death or wounding of a passenger or any other bodily injury suffered by a passenger or by his registered baggage during a course of carriage by air will be governed by the provisions of section 4,5,6 and the rules contained in the second schedule of carriage by Air Act, 1972 with certain exceptions, adaption, modification etc., as notified in the Govt. of India, Ministry of Tourism and Civil Aviation Notification No. AV 11012/5/79-A dated 5/7/1980 published in Part-II Section 3 sub-section (II) of the Gazette of India dated 19/7/1980 and amended vide notifications No. AV 11012/5/79-A dated 22/8/1989, No. AV 11012/5/79-A dated 26/3/1992 and further amended vide notification No. AV 11012/1/97-A dated 20/1/1998, as published on part 2 - Section 3 - Sub Section (II) of Gazette of India dated 31/1/1998. These conditions of carriage can be seen at any Indian Airlines office.

EXCERPTS FROM CONDITIONS OF CARRIAGE

1. The Company reserves the right, without assigning any reason, to cancel, advance, reschedule, overfly or delay the commencement or continuance of the flight or alter the stopping place or places or to deviate from the route of the journey or to change the type of aircraft in use without thereby incurring any liability in damages or otherwise to the passengers or any other person on any ground whatsoever. The Company also reserves to itself the right to refuse to carry any person whom it considers unfit to travel or who in the opinion of the Company may constitute risks to the aircraft or to the persons on board.
2. If at any stage it is found that the aircraft with the booked load of passengers etc. will be over-loaded the Company will have the right to decide which passengers or articles shall be off-loaded and such decisions shall be binding.
3. The Company is not liable for damage occasioned by delay in the carriage by air of passengers or baggage.
4. The ticket issued by the Company shall be subject to the rule of cancellation made by the Company for the time being in force which may be seen at any office of the Company on request.
5. Receipt without complaint of registered baggage on the termination of the journey shall be prima facie evidence that the baggage has been delivered correctly and in good condition.
6. In the event of death of a passenger or any bodily injury or wound suffered by a passenger which results in a permanent disablement incapacitating him from engaging in or being occupied with his usual duties or business or occupation, the liability of the carrier for each passenger shall be Rs.7,50,000 if the passenger is 12 years or more of age, and Rs.3,75,000 if the passenger is below 12 years of age on the date of accident.

Srinagar/Jammu and Leh B-737 : 75 minutes before scheduled time of departure.

The time shown on the flight coupons are the flight departure time.

Passengers are requested to arrive at the airport not later than the time stated above. Upon arrival at airport, please report at the Indian Airlines/Alliance Air counter for completion of the formalities.

'Check-In' counters for domestic services are closed strictly 30 minutes before departure. Passengers must report sufficiently in advance, in order to avoid missing the flight and inconvenience on this account.

Reconfirmation Procedures

Passengers booked to travel in groups and individual passengers who are ticketed outside India are advised to reconfirm their onward or return reservations on Indian Airlines services when they break journey for more than 72 hours at any of our stations. Failure to reconfirm at least 72 hours prior to departure in such cases may result in cancellation of the reservation. Reconfirmation is not necessary when a passenger breaks his journey at a point for less than 72 hours.

SECURITY REGULATIONS

According to security regulations, passengers are advised:

- Not to accept any packets from unknown persons.
- Not to leave baggage unobserved at any time specially within airport area. Unattended baggage may be removed by Airport/Security Staff as object of suspicion.
- To declare before check-in if carrying any arms or explosive substance. Concealment is an offence under Aircraft Act and Rules.
- To carry only one hand baggage, the sum of the three dimensions (viz., length, breadth and height) of which should not exceed 115cms.
- Battery Cells/Dry Cells carried in the hand baggage or in any electrical/electronic items are liable to be removed and airlines would not be in a position to hand-over the same at the destination. The same may be carried in registered baggage.

PROHIBITED ARTICLES

Also carriage of dry cell batteries, knives, scissors, sharp instruments, tools, fire arms, ammunitions, toy replicas is prohibited in the passenger cabin.

VALUABLE ARTICLES

Currency, Precious metals, Jewellery, Negotiable instruments, Securities, Personal identification documents and items of value are best carried with the passenger in the cabin.

RESTRICTED ARTICLES IN PASSENGER BAGGAGE

Medicines and toiletries in limited quantities which are necessary or appropriate for the passenger during the journey, such as hair sprays, perfumes and medicines containing alcohol may be carried. Many of these listed articles can be carried as air cargo provided they are packed in accordance with cargo regulations.
